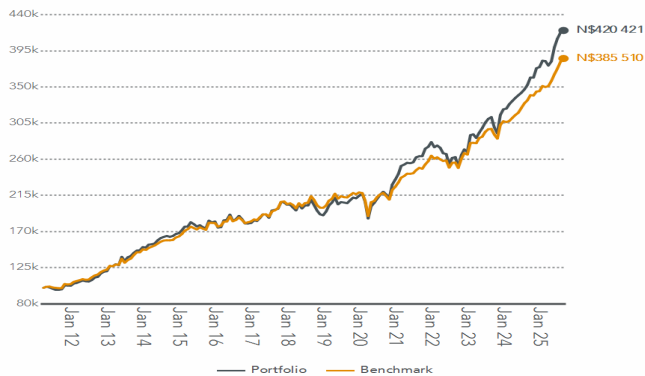

Advice Costs
