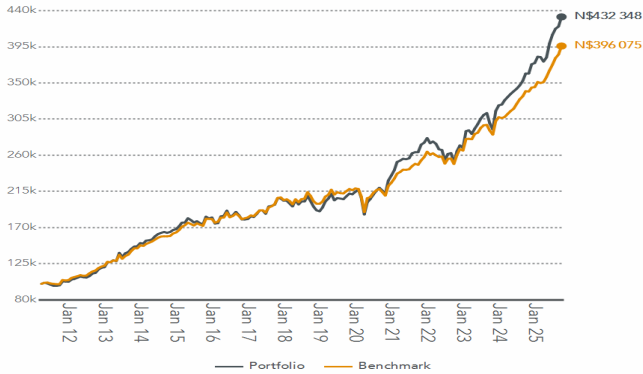

Advice Costs
