Namibia Asset Management radio and social media competition Terms & Conditions

1. Campaign overview

This promotional campaign ("Campaign") is organised by Namibia Asset Management in partnership with O&L BrandX/Radio Wave 96.7fm ("Organiser") and will run on the Namibia Asset Management social media platforms: Facebook, Instagram and LinkedIn. Competition will run for five (5) consecutive months. Each month's campaign will run for the whole month, starting from **1 July** to **30 November 2025**. By entering the Campaign, participants agree to be bound by the following Terms and Conditions.

- **Stand a Chance to Win:** your share of N\$5,000 startup investment from Namibia Asset Management.

2. Eligibility

- The Campaign is open to all residents of Namibia who are 18 years and older
- Employees including Directors of Namibia Asset Management, O&L BrandX and their advertising and promotional agencies, as well as any immediate family members, are not eligible to participate.

Every week, one person with the correct answer will earn a spot in the grand prize draw.

Grand Prize Draw: At the end of each month, the weekly winners will be entered into a grand prize draw to determine the final winner

2. How to enter the weekly draw:

- **Tune in to Radio Wave 96.7FM** from Monday to Wednesday at 14:45. Make sure you're listening to the selected radio station when the live talks start.
- **Listen for questions:** The radio presenter will ask questions during the live talk segments. Pay close attention to the questions being asked.
- **Answers can be found on the website only. Send your answer via WhatsApp** - +264 83 000 1047. Listeners can WhatsApp their answer to the studio with their **full name** and "**Nam Asset Comp**".
- Once a week, on a Friday @ 14h45, Radio Wave will choose **1 listener from that week's entries** to call live on-air.
- The host confirms their answer, engages them briefly and thanks them for entering.

How to enter the monthly draw:

Follow the steps for the weekly draw. The person who is confirmed on air for the weekly draw will be entered into the monthly draw for the **N\$5,000 startup investment** from Namibia Asset Management. Please note: Only **one entry per person per week** is allowed—unless you are selected as that week's winner.

6. Prizes

- For each month, there will be a total prize of Five Thousand Namibia Dollars (N\$5 000) for that month's campaign.
- The overall prize pool for the entire five (5) month campaign is Twenty Five Thousand Namibian Dollars (N\$25 000).
- Prizes are non-transferable and cannot be exchanged for cash or any other alternatives.
- The selected winner will be contacted by Radio Wave 96.7fm and the prize money will be directly transferred into an investment account which will be opened in their name with Namibia Asset Management.

7. Winner selection

- **Random draw:**
 - Winners will be selected via a random system draw conducted by **Radio Wave 96.7FM** at the end of each campaign month. The draw will include all valid entries received during each month (campaign dates). The draw will take place as soon as possible after the last day of entry, otherwise on the next working day, but not longer than 7 working days after the campaign ended for that month.
- **Validation of entries:**

- Winners will be contacted by **Radio Wave 96.7fm** via the contact details provided.
- Should the winners not be reachable after 48 hours, they automatically forfeit and the next winner will be contacted. **Radio Wave 96.7fm** will make 3 calls per day, which would be 6 calls in total, in a time span of 48 hours. After these attempts are made and the participant is not reachable, they will automatically forfeit their entry and the next winner will be contacted.
- Winners reserve the right to decline permission to be announced publicly on Namibia Asset Management Instagram, Facebook and LinkedIn pages. Winners that authorise **Radio Wave 96.7fm**, will be announced publicly on the **Namibia Asset Management Instagram, Facebook and LinkedIn pages** within **seven working (7) days** after each monthly draw.
- **Prize claiming:**

Personal data collected during the Campaign will be retained only for as long as is required by law.

- **Right to withdraw consent:**
